The workshop will take place at the Catholic Academy in Bavaria, Mandlstraße 23, Munich.

Please be aware that the currently valid Covid-19 protection measures for Bavaria will be enforced at the event. On 4 February 2022 these include:

- **2G+ rule at the venue**: Participants need to provide proof of recovery or of receiving 2 vaccine doses as well as a negative PCR test (48 hours). In case of a 3rd vaccination dose (booster) the PCR test is not required.
- **2G rule in gastronomy and accommodation**: Participants need to provide proof of recovery or of receiving 2 vaccine doses.
- Mandatory FFP2 mask indoors when not seated and maintaining safety distance or at the table in a restaurant.
- Mandatory 10-day quarantine when entering Germany can be avoided by providing proof of recovery or vaccination prior to entry.

We will inform all the registered participants about the latest status in the week before the event.
